While the App provides tools to aid in the organization and communication during an evacuation, it is intended as a supplementary tool and does not replace or guarantee proper emergency procedures, nor does it ensure the accuracy or success of evacuations. By using the App, you acknowledge and agree to the terms of this legal disclaimer, including the understanding that [Evac], its developers, affiliates, and partners, are not responsible for any injury, death, or damage that may occur during its use.

1. No Liability for Injury or Death

The App is provided **as-is**, without any warranties or guarantees of accuracy, reliability, or performance during an emergency. While the App aims to aid in the organization and communication of evacuation efforts, **it is not a substitute for professional emergency management, fire safety protocols, or on-the-ground response measures.**
